If you purchase a Pet, Show Alter, you as the purchaser agree that the above feline will be surgically neutered or spayed by 6 months of age, latest 8 months. A veterinarian certificate will be needed to be faxed or mailed to myself for proof of de-sexing. Failure to do so can result in repossession of kitten which is a legal right of the breeder. Once the proof of de-sexing has been approved, I will then forward to you registration papers for the above feline (if registration requested and paid by purchaser).

If a breeder has been purchase, and shows no interest in breeding by the age of 2 years old, then a replacement shall be offered, they may not be the same coloring, however, will be of same value.

You, as the purchaser, are expected to bring your kitten for a vet exam within 1 week to ensure good health of the above feline. You are, as the pet owner responsible for all your pet annual exams and follow up vaccines and worming treatments, the vaccines are important to control the Herpes strains that are changing.

Precious Luv Cattery guarantees their kittens to be free of all genetic ailments for one year from the purchase date above. Should a problem arise, please notify me immediately, veterinarian proof will be required. If it is determined to be a health or life issue, only then, will a replacement kitten will be provided. The sick kitten is to be returned at purchaser's expense, replacement kitten shipment costs will be at the purchaser's expense. Replacement feline of the same value, will be provided, there are NO REFUNDS issued under any circumstances. Please understand that there may be a waiting period until there is an available replacement kitten. I do all I can to ensure all kittens are of great health, however, there are times nature might have different plans, same as in us humans.

Under no circumstances, will you allow the veterinarian to administer a Feline Leukemia Vaccine, as this can cause heart issues for Ragdoll felines. By doing so, it will VOID this contract. As the purchaser of the above feline, you agree to the following for a good healthy life for the feline:

- 1) Clean fresh water and food at all times, clean litter box provided.
- 2) Annual exams and necessary boosters update by a certified veterinarian. FVRCP booster and Rabies vaccine are never to be given at the same time, as a potentially life threatening reaction can occur. We do not warrant against feline have adverse reactions against future vaccines.
- 3) Cleaning of teeth when necessary.
- 4) Provide the feline a scratch post or cat tree to prevent the feline from wanting to use furniture.
- 5) Under no circumstances is the feline to be declawed, this will **void** this contract, and is extremely cruel.
- 6) Will not abuse the feline in any way or form. These are our gifts from above and should be treated as such.
- 7) Never allowed cat outside unattended, they should be in an enclosure or on a leash at all times.
- 8) If feline became sick within the 1st year, you as the Purchaser will bring immediately to a veterinarian, (if not eating or drinking and become lethargic or injured), also notify Precious Luv immediately. Failure to do so with render all health guarantees NULL and VOID. All cost will be the Purchaser's responsibility. Replacement kitten will be provided, as long as was a health issue.
- 9) NO VETERINARY EXPENSES OR MONETARY REFUNDS FOR FELINES PURCHASED FROM PRECIOUS LUV CATTERY WILL BE GIVEN FOR ANY REASON.
- 10) The Purchaser agrees to not lease, sell or give the feline to any pet store, animal shelter or research laboratory. If the Purchaser is no longer able to keep the above feline, the Seller has first rights to the said feline.

Precious Luv will send your bundle of joy home with his/her first vaccines, worming, health record, along with a microchip, details to upload your information. The above feline will be sent to you free of internal parasites, including fleas. Viruses, colds and upper respiratory infections are not covered by this guarantee, as they can be contracted after leaving our cattery and are not due to genetics or breeding; 97% of **all** cats are Herpes positive. Most never have any signs, if they get watery eyes, from stress, medication helps and are cheap. Unfortunately, in this day and age, there still are no cures, percentage of positive keeps going up. Which is why booster vaccines are important?

Our Breeders are all HMC, FELV, FIV, and Panel tested Negative. We have no control of what your feline is in contact with once it leaves our cattery. Your kitten is leaving its first home healthy. We have no guarantee for the size and coloring of the feline, as they all vary; colors take 2 years to complete. I will also provide you with the feeding information and if you are not able to purchase the same food in your area, I will send you some to cover the transition period for switching of the food.

Precious Luv has the right to refuse the release of the feline if Purchaser shows that they would not be the right fit for our Precious Luv Feline kittens. We want only the best homes for our beautiful Precious Luv gifts! We love all our felines and want them to have the same loving homes that they were first raised in.
